

PARTICIPATION TERMS

for Participating at the Tábor Meetings Festival

PARTICIPATION TERMS

By entering the venue of the festival (determined by the organizer), the participant accepts the conditions and must comply:

A) FESTIVAL PARTICIPANTS ARE STRICTLY PROHIBITED FROM:

- bringing and using glass containers (including bottles), combustibles and explosives, weapons of any kind, psychotropic substances, items which may pose a risk to safety, pyrotechnic items, laser pointers
- making an open fire
- distributing or placing any promotional or advertising materials on the festival grounds without written consent by the organiser for doing so
- the consumption and the distribution of drugs at the festival except those which are legally available in the Czech Republic (tobacco, alcohol) is strictly prohibited.
- observe prohibition of entrance beyond the restricted premises and to any objects marked with the safety sign "Entry Prohibited"

B) FESTIVAL PARTICIPANTS UNDERTAKE TO:

- maintain good standards of tidiness
- behave politely to other festival participants and to the organisers, and not to disturb the course of the festival in any other way
- do not use the logo or protected trademark of the festival without the written permission of the festival organiser
- hand over items found in the area of the festival to the representatives of the festival organizer
- Observe conditions for taking part in the festival, organisers' instructions and legal regulations

C) IN TERMS OF SAFETY THE FESTIVAL PARTICIPANTS UNDERTAKE TO OBSERVE THE FOLLOWING INSTRUCTIONS

- to provide adequate personal assistance while extinguishing a possible fire or handling a natural disaster or another extraordinary event unless they expose themselves or other persons to serious danger or unless an important circumstance prevents them from providing such help, and to provide material help
- pay attention not to cause any damage to property and the health of any third party
- to throw ash and cigarettes butts and other tobacco products only into designated containers; To practise safety while lighting tobacco products (matches, lighters)
- not to smoke in areas and grounds marked with the sign "Smoking Prohibited"
- not to damage the safety signs in place
- not to damage portable fire extinguishers in place and not to limit their use in any way
- not to damage hydrant systems and other fire safety devices and not to limit their use in any way
- not to damage electrical devices in place and not to encroach on them in any way
- not to damage control elements of the technical devices installed (switchboard panels
 for electrical devices, main switches, main water seals, etc.) and not to restrict their
 use in any way
- to notify representatives of the festival organizer when you find anything, that could cause a hazard to safety or property

- inform the representatives of the festival organizer, if you notice any injured person
- to observe instructions given by the event organiser, by members of the preventive fire patrol, by security guards, or by members of the integrated rescue system intervening units in the event that a fire alarm has been sounded

D) PARTICIPANTS OF THE FESTIVAL:

- assume full personal responsibility for participating at the festival
- please take into account, that the festival takes place in any kind of weather
- are liable for all damage that they cause
- the festival visitors agree in all cases by entering the festival site that photographs and video recordings with themselves (including their children), which are made during the festival, can be used by the festival organiser for any promotional or other purposes, in any form and for free

E) THE FESTIVAL ORGANISER IS ENTITLED TO DO THE FOLLOWING:

- to withdraw from the Contract for Participation at the Colours of Ostrava Festival in the event it is breached on behalf of the participant, and to accompany the festival participant out of the festival premises or site with the aid of the security service and not to allow the participant to reenter the premises
- to give necessary instructions to the festival participants in order to maintain the seamless running of the festival, safety of participants, and protection of property
- to change the line-up, including the participants, in the event of unexpected events (weather conditions, accidents, health condition of the participants, etc.)
- to change these conditions with immediate effect, if deemed necessary

F) THE ORGANISER OF THE FESTIVAL:

- is not liable for damage to property or health of the festival participants unless this damage is caused as a result of violating legal regulations by the organiser and in direct relation to this violation
- is not liable for any loss, damage or theft of items, except for those which were taken into safe custody (eg. lockers)
